This is in reference to your application no. 01251892315C0098 dated 20-09-2023 regarding the Fire Safety Certificate for existing construction of G+III storied School Building in the name & style "TECHNO INDIA GROUP PUBLIC SCHOOL" under group Educational Building at Mouza-Rangamati And Narampur, Vill.-Rangamati, P.O.-Vidyasagar University, P.S-Kotwali, Midnapore, Ward No- 24, Under Midnapore Municipality, Pin-721102.

The performance of the Fire Fighting System as incorporated in the buildings were tested at random and found satisfactor.ly working condition. In view of the above this office is releasing the Fire Safety Certificate for occupancy of the aforesaid building.

Recommendation: 5

- 1.Driveway must be free of any type of obstruction for easy movement of Fire Appliances. Parking must not be allowed on the Drive way.
- 2.The Interior finish decoration of buildings shall be rande with low flame spread material confirming to the I.S. Specification
- 3.To eliminate risk of Fire Hazards, Good House Keeping both for Insides and outside of the buildings shall be strictly maintained.
- 4.Existing Electrical wiring of the whole buildings shall have to be carefully checked for any wear and tear in them, particularly lines above false coiling & ducts.

- 5.A Fire control room including a closed circuit TV system shall have to be maintained which observe all the floors of the building
- 6. The notice of Fire Fighting and Evacuation from the buildings shall be prepared and displayed at all vulnerable places of the Buildings.
- 7. The employees and security staff shall be conversant with installed fire fighting equipments of the buildings and to operate in the event of fire and testing.
- 8.Mock Fire practice and evacuation drill shall be performed periodically with participants of all the occupants of the buildings.
- 9.Transformer and switch gear shall be protected with automatic CO2 or DCP Fire extinguishers confirming I.S. specifications.
- 10.A trained Fireman shall be maintained round the clock for fire safety of the building.
- 11. First Aid fire fighting system shall be provided as per I.S. specifications.
- 12.Arrangument shall have to be made for regular checking, testing, and meintenance of all the Fire Fighting installation in the Buildings to keep them in perfectly good working condition at all the times.
- 13.If required the old electrical lines shall have to be replaced with new lines. The cables shall always be laid in M.S. conduit pipes continuously bonded to the earth.
- 14. Electrical Ducts shall have to be sealed vertically and horizontally in proper manner immediately.
- 15.Periodical flashing of water in the Hydrants pipe line shall be made to maintain the efficient working performance of above mentioned system.
- 16. Fire Chack door shall be sealed with rubber sealing properly in order to prevent percolation of smoke.
- 17. Existing lift shall be trouted as Fire Lift in case of emergency.
- 18. The Fire Safety audit to be conducted at regular interval and to be recorded in the Fire Prevention maintenance register.
- 19.This Fire Safety Certificate is valid for three years and has to be renewed every three years from the date of issue of this letter.
- 20. This certificate is to be obtained from the Director General, West Bengal Fire & Emergency Services regarding performance of all the Fire Safety arrangements and Installations of the building.
